The SWAMP was written during academic year 2019-2020, and finalized into 62 items in April 2020. Students sat for the closed-book exam during their final exam period for SWRK 6201 (HBSE II) for 3 hours (Spring 2021), and Advanced Standing MSW students took the SWAMP as their final exam after completing SWRK 6050 "Bridge Course" (early August 2020). During the 2020-2021 academic year 26 students completed the SWAMP.
